The meeting was called to order at 1:31 p.m.

Health Department

1. 1st & 2nd reading; Abatement of a property located at 9705 North Route E, parcel # 11-100-06-02-003.00 01

Britni Hendren said they received an anonymous complaint on November 6th and investigated the complaint on November 10th. In view were five cars, wrecked and not in driving condition, plus rubbish throughout the front yard.

Upon speaking with Kala and Commissioner Miller about the cars, we were instructed to proceed. A violation letter was issued on November 12th by Certified Mail and signed for on the 18th. A re-inspection was done on December 4th and nothing had changed. A hearing notice was sent to the owner for the meeting today. There has been no contact with the owner. Another inspection of the property was done on December 12th and the property stilled looked the same.

Commissioner Miller asked if there is an estimate on cleaning up the property.

Ms. Hendren said she has sent an inquiry to the contractor about removing the rubbish and has not heard back. There are five cars and I-70 towing is charging \$50/car for a total of \$250.

Commissioner Atwill asked if there is money in the budget for this kind of charge.

Commissioner Miller said that some clean-up efforts have cost between \$300 and \$400.

Commissioner Miller asked Ms. Hendren if she knows the budget balance.

Ms. Hendren said she did not know but will find out and advise the Commission.

Purchasing and Public Works recommend award to all three vendors. County will order each product from the Contractor offering the lowest price during each 4-month term of the contract. Contractors will be allowed to adjust prices

for the renewal terms, provided proof of manufacturer's price increase can be furnished to the County. Proposed price adjustments will be evaluated at each renewal period by the County and City of Columbia to determine if the contract will be renewed or re-bid. If renewed, purchases will be made from low bid, by line item, from the Contractor(s) offering the lowest price by line item.

This Term and Supply contract will be paid out of County department 2040-PW Maintenance Operations, account number 26400-Road Oil with \$480,000 budgeted.

Attached is a copy of the bid tabulation for your review.

There were no comments or questions.

Commissioner Thompson moved on this day, the County Commission of Boone County adopts the Boone County operating budget for fiscal year 2015. The adopted budget shall consist of all appropriations included in the Proposed Budget submitted to the County Commission by the County Auditor, subject to the adjustments shown in the attached Schedule of Changes to the Proposed Budget.

Total appropriations are set forth by line item and are summarized as follows:

- 1) by category of expenditure (i.e., class 1, class 2, etc up to and including class 9.);
- 2) by office, department or spending agency; and,
- 3) by fund.

Appropriations may not be exceeded at the class level for a given office, department, or spending agency without approval pursuant to the County's Budget Adjustment Policy. Total appropriations for each fund are set forth in the individual Fund Statements and are published in the County's FY 2015 Budget. The Proposed Budget submitted by the County Auditor, which is hereby incorporated into this appropriation order by reference, contains

detailed documentation and descriptions for each line-item account within each category of expenditure. Appropriations shall be expended only for the purposes that are within the intent of the category in which they are included.

The County Commission approves all employee positions included in the Proposed Budget, adjusted for Commission changes noted in the attached schedule, together with the specified budgeted hours, range, and benefit status for each position. Appropriations for salary and wage *increases* within the Road and Bridge Fund pertaining to employees operating under the Collective Bargaining Agreement (CBA) are contingent upon revision and approval of the CBA.

The County Commission approves appropriations for the specific fixed assets identified in the various fixed asset appropriation accounts and authorizes procurement of the same in accordance with the Budget Adjustment Policy and the County Purchasing Policy adopted by the County Commission.

The County Commission authorizes the County Auditor to re-appropriate unspent FY 2014 grant funds (which may be carried forward into FY 2015 according to the terms of the grant award) upon determination that a remaining balance of the grant award is available for rebudgeting.

Commissioner Miller seconded the motion.

9. First reading; Consultant Services Contract with Howe Company, LLC

Stan Shawver said this is a proposal for Consultant Engineering Services with Howe Company to perform a hydraulic analysis and preliminary report on two sites in Boone County; Red Rock Road and Mt. Zion Church Road.

There are large culverts under each road and there is a tendency, when water is up, to collect debris causing a maintenance issue resulting in a clean up operation to restore flow. We have asked Howe Company to evaluate the sites and make some recommendations on different designs that would replace the existing culverts so there is less intensive maintenance involved.

Commissioner Miller said the property was considered a public nuisance and we have an ordinance that gives the Health Department the authority to act on that nuisance, if it is granted by the Commission to do so. In today's meeting, we gave them that authority to remove the cars and rubbish.

Ms. Sanders said that the house is currently being remodeled and it is not rubbish. The cars have been wrecked, but are licensed. She is trying to get rid of the cars and is waiting on the

State to get her the titles.

Commissioner Miller said that she will need to contact the Health Department as they have the authority to work with her on the problem even after the order has been issued. The contact at the Health Department is Britni Hendren.
