The meeting was called to order at 1:30PM and roll call was taken.

Employee Recognition

1. Boone County Employee of the Fourth Quarter 2023 recognition

2. First and Second Reading: Authorization of Salary Adjustment for Position 209, Custodian due to change in County Policy 3.10 Shift Differential

Director of Human Resources Angela Wehmeyer stated, at the beginning of the year, the County changed the shift differential policy. Director Wehmeyer stated this employee is still within their six-month probationary period and was hired under the old shift differential policy so she is asking for a salary adjustment for this employee that isn't merit-based but will take into account the policy change.

Boone County, Missouri received ARPA Grant Funding from the federal government and the County Commission engaged in an RFP process to determine ARPA funding awards.

This ARPA Award is for County Contract # C000720 - Centralia Sewer Lining with the City of Centralia, Missouri. This project is for the City of Centralia to line approximately 12,500 feet of sewer pipe with "Cure in Place Pipe". Lining the sewer pipes will strengthen and seal pipes, preventing raw sewage from leaking out of broken pipes and preventing ground water contamination and sickness.

This ARPA award is for County contract# C000722- Water & Sewer Infrastructure with the City of Sturgeon, Missouri. The ARPA funds will be used to improve sewer and water infrastructure impacting the community. The funds will be used to purchase a Vac Trailer, which will enable the community complete lead line inventory as required for DNR compliance, keep meter pits cleaned and replaced when needed, and allow for safer and more efficient digging as existing utilities in the ground can be located easier and striking them can be avoided. Additionally, the funds will be used for lead line inventory, as required by MO DNR.

Director of Purchasing Melinda Bobbitt read the following memo:

Boone County, Missouri received ARPA Grant Funding from the federal government and the County Commission engaged in an RFP process to determine ARPA funding awards.

This ARPA Award is for County Contract # C000723 - The Shops at Sharp End with the Central Missouri Community Action. This project is to further CMCA's retail incubator Shops at Sharp End. This includes the renovation and operational costs for their current office space at 500 E. Walnut Street in Columbia Missouri to provide retail space, conduct business training, coaching and peer to peer mentoring. Additionally, funds will be used to staff the retail incubator with a retail manager and business coach as well as provide scholarships for people to receive business coaching and training at a discounted rate. The goal of the Shops at Sharp End is to reduce barriers to entry for low to moderate income individuals and minority populations who want to start up retail enterprises, with a special focus on reaching 51% of minority business enterprises. Through participation in the project, individuals and businesses will gain assistance in becoming financially viable, freestanding, successful business owners.

Contract Award is for a not to exceed amount of \$397,821.00, and will be paid from Department 2983 - American Rescue Plan Act, Account 82400 - Other Contracts.

19. Commissioner Reports

Commissioner Thompson stated the National Association of Counties begins its annual legislative conference on Saturday, for which she and Commissioner Aldred will be traveling to Washington D.C. Commissioner Thompson stated that she and Commissioner Aldred both sit on many committees, and she hopes to bring back good information for Boone County. Commissioner Thompson stated the second item she would like to discuss is that earlier this week, but after the Tuesday Commission meeting, a member of the public, Kenny Lancaster, who has property adjacent to the Heuer's Country Store and Restaurant, and who lives on that property, wanted to express his concern about allowing Mr. Heuer authorization to have his restaurant open at that location. Commissioner Thompson stated Mr. Lancaster described in graphic detail what he, as a neighbor, has endured. Commissioner Thompson stated Mr. Lancaster complained about, when moving his yard, instead of enjoying a bit of dew hitting his face, bits of excrement hit him in the face because Mr. Heuer's lagoon was failing. Commissioner Thompson stated, Mr. Lancaster also informed them of many times Mr. Heuer had laid down garden hoses across his property to pump sewage out of his lagoon, and at one point, Mr. Heuer, instead of pumping it into a container to take off the property, had directed the hoses into the creek, pumping sewage from his lagoon into the creek. Commissioner Thompson stated Mr. Lancaster was concerned and asked the Commission to assure him that Mr. Heuer would no longer engage in that kind of conduct, and as they said on Tuesday, they wish they could be assured of that. Commissioner Thompson stated the Commission has hope, they are obligated to follow the regulations and, if Mr. Heuer complies with the regulations, he will be allowed to remain open.

Commissioner Kendrick stated he saw in an email a minute ago, a receipt from Mr. Heuer where he is requesting a pre-inspection as the project is close to being complete.
