B. Second Reading and Award of Bid 70-07OCT03 (Applewood Creek Neighborhood Improvement District)

Marlene Ridgway stated this is a recommendation for award to C. L. Richardson Construction Company for offering the lowest bid meeting specifications. Total cost of contract is \$103,840.50.

Commissioner Elkin moved to award bid 70-07OCT03 for the Applewood Creek Neighborhood Improvement District to C. L. Richardson Construction Company Inc.

Total estimated 3 year value is \$20,975.77. Identified purchase for 2003 include a contract amount of \$5,978.50 for the Collector's Office.

D. First Reading of Bid 69-02OCT03 (Snow and Ice Control Services)

Marlene Ridgway stated the Public Works department and the Purchasing department have reviewed the bids submitted and recommend awarding 15 trucks at the responded prices. The recommended award is as follows:

Diamond "C" Services - 1 truck at \$275/hour and 3 trucks at \$250/hour

Grant Excavating - 1 truck at \$285/hour

Executive Lawn Service – 2 trucks at \$285/hour

JC Landscaping - 1 truck at \$285/hour

Highpoint Enterprises – 6 trucks at \$200/hour

Doug Biollot – 1 truck at \$288.40

These services are to be paid from organization 2040 account 71100. This is a term and supply contract that runs through September 30, 2004.

David Mink, Public Works Director, noted the bid was restructured from the 2002 bid and explained the differences. He believes the \$2 million insurance requirement is one reason why the prices are so high. Last year there were only nine trucks and believes this was no a sufficient number to perform the services to the citizens in subdivision.

Commissioner Elkin commented on how he thought the bids were still very high.

The Commissioners and Mr. Mink discussed how this bid may be done in the future.

Subject: Emergency Management Joint Communications

A. First Reading of Contract with City of Columbia (Homeland Security Grant) and Budget Amendment

Jim McNabb stated this is an annual grant from the Office of Homeland Security, administered by the State Emergency Management Agency. This agreement is with the City of Columbia, with the sub-grantee being Boone County. The Boone County Public Works Department and Sheriff's Department are included in the departments that will be receiving funds from this grant.
