1. Public Works (All First Readings)

A. Approval for new consultant: Terra Technologies

On May 1, 2006, the beginning balance in the C.A.S.H. County Program was \$57,493.82. Donations during the month were \$2,027.81, interest was \$92.47, and disbursements totaled \$4,403.11, leaving a balance of \$55,210.99.

On May 1, 2006, the beginning balance in the H.E.L.P. County Program was \$11,712.28. Donations during the month were \$1,541.78, interest was \$18.84, and disbursements totaled \$3,285.55, leaving a balance of \$9,987.35.

7. Public Comment

Commissioner Schnarre and David Mink discussed compensation for the employee who has been filling in for a public works employee who has been on worker compensation for the past 7 months.

According to MOU in order to get a step up pay of 3% you must work 80 hours, which they would like to have waived. If they give him a promotion, it is with the understanding that when the work comp employee comes back, it will be taken back.
