1. Sheriff's Department

Captain Beverly Braun, Sheriff's Department was present on behalf of these items.

A. Establish Budget for Undercover Vehicles

J. 05-08 Skid Steer with Attachments

Ms. Turner reported the bid for a Skid Steer and Attachments closed on February 8, 2007. Five bids were received. The low bid received from Bobcat of St. Louis did not meet the following minimum technical specifications:

- 87 Horsepower (bid required 88 HP)
- 8,448 lb Operating Weight (bid required 8,950)

- 80" Bucket (bid required 82")
- 78" Grapple Attachment (bid required 82")
- 76" Tiller Attachment (bid required 78")

Therefore Purchasing and the Public Works Department recommend award to the 2nd low bid, Crown Power & Equipment, which met or exceeded all minimum technical specifications.

Total cost of the contract is \$46,362.00 including the tiller attachment, grapple attachment, and an optional door/window/heater to be paid out of department 2040 - PW Maintenance Operations, account number 91300 – Machinery/Equipment. The budgeted amount for this purchase was \$44,500.00. Please see the attached memo from Greg Edington regarding the amount over budget.

There was no discussion and no public comment.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

K. C107175004 Ammunition Term & Supply

Ms. Turner stated Purchasing requests permission to utilize the State of Missouri cooperative contract for Ammunition with Oklahoma Police Supply, LLC. The Purchasing Department issued a bid for Ammunition that closed on December 14, 2006. At that time, there were no bids received on the Remington Golden Saber ammunition. In order to have a contract in place for this ammunition, the Purchasing Department would like to utilize the State of Missouri cooperative contract for 40 caliber Remington Golden Saber Ammunition.

This term and supply contract will be paid out of departments 1251-Sheriff, 1255-Corrections, and 2901-Sheriff Operations, LE Sales Tax, Account 23200-Ammunition.

There was no discussion and no public comment.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

3. Public Works

A. Budget Revision - Design and Construction

This revision will move funds from the Design & Construction budget to cover the budget shortfall in the Rebates to Special Road Districts account.

There was no discussion and no public comment.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

B. Request to hire above mid-point

Commissioner Miller moved now on this day the County Commission of the County of Boone does hereby approve the request to hire above Mid-Point for the Project Engineer, position number 606-2045 in the Public Works Department.

Commissioner Elkin seconded the motion

There was no discussion and no public comment.

The motion passed 3-0 Order 102 -2007

C. Speed Limit change for Schooler Road

Mr. Andrew Dick, Public Works was present on behalf of this item.

Mr. Dick reported the Boone County Public Works is recommending raising the speed limit on Schooler Road from State Route U to State Route 124, from 35 mph to 45 mph.

Schooler Road has been recently reconstructed from gravel to asphalt. The upgrade from gravel to asphalt pavement prompted this speed limit study.

The speed limit for this section of road before it was paved was 35 mph and has remained at 35 mph after constructing it to asphalt. The default speed limit for asphalt paved roads according to Section 1.4 of Boone County Roadway Regulations, Chapter 1, is 40 mph.

According to Section 3.5 of the Traffic Safety Manual for Boone County, MO., "A posted speed limit shall be changed only by Commission Order."

A traffic study was completed 10/2/06 to 10/3/06, to monitor speeds on Schooler Road using Nu-Metric Traffic Analyzers. The study was performed to determine the speed limit for the road based on the 85th percentile. This is because the Manual on Uniform Traffic Control Devices (MUTCD), 2003 Edition, states that when a speed limit is to be posted, it should be within 5 mph of the 85th percentile speed.

Total 85th percentile speed average = 46.45 mph

Based on the sample of data from the traffic study, it is apparent that Schooler Road would be within 5 mph of the 85% percentile speed average if the speed limit is increased to a 45 mph speed limit.

The speed limit suggested is also in accordance with Section 1.4 of Chapter 1 of Boone County

Roadway Regulations, Section 3.2 of the Boone County Traffic Safety Manual, and Section 2B.13 of the Manual on Uniform Traffic Control Devices 2003 Edition.

The speed limit will not be raised to 50 mph which is still within the 85th percentile because of the road's edge drop shoulder conditions.

Commissioner Miller explained this was the first of three hearings which will allow the opportunity to respond.

4. Auditors

June Pitchford, Boone County Auditor was present on behalf of this item.

A. KPMG LLP Engagement Letter for FY 2006 Financial Statement Audit Services

Ms. Pitchford explained KPMG is an independent auditor. This agreement is to provide independent audit services to the County of Boone for fiscal year 2006. The scope of the proposed services includes an audit of the County's financial statements as well as an A-133 audit, which is an audit of federal grant programs. KPMG was selected through an RFP process and has provided audit services to the County since fiscal year 2000. The proposed engagement letter reflects a 5% increase over that of the prior year.

B. Budget Revision 4th Quarter Unemployment

Ms. Pitchford stated this revision was to cover FY2006 4th quarter unemployment expense.

There was no discussion and no public comment.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

5. Commissioner Reports

6. There was no public comment

Commissioner Elkin reported Boone Hospital is running approximately 67 days behind on construction due to weather. The Parking garage should be complete in late August 2007.

The Bluffs – The administrator is leaving and they are in the process of locating a replacement.
