2. Sole Source Purchase – 81-123108SS – Digital Evidence Networked Server and DEP Application Software (first reading)

Ms. Bobbitt stated the Sheriff Department requests permission to make a sole source purchase due to only one feasible source being available to purchase Digital Evidence Networked Server and DEP Application Software, Single workstation, Backup/Archiving Station, Training, Wireless Access Points (2), Surge Protector.

The Sheriff's Department purchased (10) L3 Flashback in-car digital videos camera systems for patrol cars in 2007 on bid 6863. Due to budgetary constraints the server, workstation, archiving system, wireless access points and training were not able to be purchased in 2007, and were budgeted for 2008.

The system allows for the wireless transfer of the in-car digital video to a server housed at the Sheriff's Department. The items described within this sole source request are critical to the

system as they are designed to specifically communicate and operate with the in-car digital videos cameras the department already has purchased. The system maintains the video for a set period of time and then either drops it from the system or archives the video to a DVD.

The purchase is with L3 Communications Mobile-Vision, Inc. of Boonton, New Jersey, for a total of \$23,989.00 and will be paid from Department 2901 – Sheriff Operations LE Sales Tax, Account 91301 – Computer Hardware. \$23,939.00 was budgeted for 2008.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

3. Agreement with Acme for Installation of Safety Hooks (first reading)

Commissioner Miller stated this contract is to install safety hooks onto the outside of the courthouse for workers who will be working on the roof of the new expansion. She stated this is a new contract instead of a change order because the contractor for the steel (Seward) did not want to assume the liability of the safety hooks being installed by the subcontractor (Acme).

Total cost of contract is \$2,400.00 and will be paid out of Department 4061 – Courthouse Expansion, Account 71201 – Construction Costs (Materials). Installation of Safety Hooks was not a part of the original budget and will have to be paid from construction contingency.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby approve the agreement with Acme Erectors, Inc. for Installation of Safety Hooks in the Courthouse. It is further ordered the Presiding Commissioner is hereby authorized to sign said agreement.

5. Surplus Disposal – Voice Stress Analyzer Laptop Computer, Asset Tag 12468 (first reading)

Mr. Boldan stated the bid for Corrections Uniforms Term and Supply closed on February 26, 2008. Five bids were received. Purchasing and the Sheriff's Department recommend award to ED Roehr Safety Products for offering the lowest and best bid for Boone County.

This is a term and supply contract and invoices will be paid from Departments 1255 – Correction and 2902 – Corrections-LE Sales Tax, Account 23300 – Uniforms. \$20,000.00 is budgeted in 1255 and \$5,652.00 is budgeted in 2902.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

7. Cooperative Contract – C305116001 – Fluorescent Bulb and Non-Rechargeable Battery Recycling (first reading)

Ms. Bobbitt stated Purchasing and Facilities Maintenance request permission to utilize State of Missouri cooperative contract C305116001 – Fluorescent Bulb and Non-Rechargeable Batter Recycling with HTR, Inc. of Lake Ozark, Missouri.

Invoices from this term and supply contract will be paid from Department 6100 – Facilities and Grounds Maintenance, Account 71100 – Outside Services. \$1,575.00 was budgeted for bulb recycling for 2008.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

8. Budget Revision to Purchase Security Software (first reading)

Commissioner Miller stated the money for this purchase was budgeted in Contingency, and this revision is to move it from Contingency into Computer Software so the Information Technology Department can purchase security software for the BooneDev portion of the AS400.

9. Grace Lane Repair Project (first reading)

10. Rustic Road Culvert Replacement (first reading)

20 acres, more or less, in the northwest part of the northwest quarter of said Section 4 described as BEGINNING at the southwest corner of Section 33, Township 48 North, Range 12 West; thence South onto said Section 4 a distance of 4.17 chains (275.22 feet) to the county road; thence up said road with the meanders thereof to the township line; thence West along the township line to the POINT OF BEGINNING.

The above described tract contains 320 acres, more or less.

Said adjustment shall be effective upon Commission approval.
