# 1. Country Hills Subdivision Storm Sewer Improvements (first reading)

Mr. Campbell stated when we set up the original design engineering contract, they were going to do it where we either bid it all at one time, or we would bid it in two different parts with the engineering done in two different stages. Doing the engineering in two different stages would have cost a lot more than doing it all at the same time. They are going to engineer everything at the same time, but we are going to be bidding it at different times. We went with the lower design contract fee in the beginning, and this is an increase to reflect their additional cost to do two bids. It is an increase of \$3,670.50.

Commissioner Miller asked if we are bidding some of it this year.

Mr. Campbell stated we are pretty close to bidding part of it.

Commissioner Pearson asked which part we are doing.

Mr. Campbell stated we are doing Phase I, which is on the southern side in the cul de sac.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting following the mandatory 10 day waiting period with an appropriate order for approval.
