The meeting was called to order at 9:30 a.m.

#### **Courts**

Pete Bakutes with Court Services was present on behalf of this item.

#### 1. Demonstration Monitoring Service Agreement (first reading)

Mr. Bakutes stated this is a no cost contract to Boone County it pertains to the 30-day free try out period for the alcohol monitor equipment that is replacing the sobrieters that the County has used for at least forty years. These give more continuous leads at any time that is wanted. The cost will continue to be the same as the old units used. This contract was reviewed by County Attorney CJ Dykhouse and he found some things to change in it. The vendor was kind enough to accept all of the changes. With a free trial period the company also provides full services such as monitoring and data entry, paying shipping, paying any phone charges. One of the items removed was the loss provision which would require the County to pay if an item was damaged. Mr. Bakutes stated this is really a great opportunity for the County with no exposure.

Commissioner Pearson inquired how the units worked.

Mr. Bakutes stated this unit is strapped around the ankle and can be tested through the skin at any time.

This allows the County to buy when we need it instead of purchasing a whole bunch of them and have them sitting until they can be utilized. There are just a lot of positives from buying off of these contracts.

Mr. Gish stated IT Department still does shop around even though these cooperative contracts are available. IT Department continues to check to ensure that the County is around 5% for purchases.

Commissioner Pearson stated by using cooperative contracts as a whole, conceptually, the County is receiving more marketable prices.

Commissioner Miller stated there are several cooperative contracts now, not just one. This enables us to compare all of those prices.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby approve the request by Information Technology Department to purchase laptop computers, personal computers, peripherals and printers from cooperative contracts World Wide Technology, Inc., National Association of Counties, and Western States Contracting Alliance, for the FY 2010.
