The meeting was called to order at 8:30 a.m.

Purchasing

Tyson Boldan from Purchasing was present on behalf of these items.

1. 06-01Feb10 Road Construction Equipment (first reading)

Mr. Boldan stated the Bid for Road Construction Equipment Term and Supply closed on February 01, 2010. Seven bids were received. Purchasing and the Public Works Department recommend primary, secondary, and tertiary award between Hertz Equipment Rental, Bobcat of St. Louis, Fabick CAT, Roland Machinery, RSC Equipment Rental, and TriState Construction Equipment by line item.

This is a term and supply contract. Contract will be paid from department 2040 – Public Works Maintenance Operations, Account 71700 – Equipment rental. \$35,000 is budget in this account for the 2010 Year.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

2. Surplus Disposal of a Photocopier 12541 (first reading)

Mr. Boldan stated purchasing requests permission to dispose of the Circuit Clerk's copier, fixed asset tag 12541. We will be purchasing a new copier from cooperative term and supply contract 42-09DEC08. Attached for signature is the Request for Disposal form.

3. 12-18Feb10 Lien Search and Title Search (first reading)

Mr. Boldan stated the Bid for Lien Search and Title Search Services Term and Supply closed on February 18, 2010. Four bids were received. Purchasing and the Boone County Collector recommend award to True Line Title Company for offering the lowest and best bid for Boone County..

This is a term and supply contract. Contract will be paid from department 1150 –Collector, Account 84500 – Title Search. \$34,024 is budget in this account for the 2010 Year.

4. 08-08Feb10 ISCSI SAN (first reading)

Mr. Boldan stated the bid for ISCSI SAN Equipment closed on February 8, 2010. Two bids were received. Purchasing and the Boone County Information Technology Department recommend award to SMC Electric for offering the lowest and best bid. This is a one time purchase. Purchase Orders will be paid from department 1170- Information Technology, Accounts 91301 Computer Hardware, and 92301 Replacement Computer hardware. \$6,487.00 will be paid from each account for a total cost of \$12,974.00.

Chad Martin from the Sheriff's Department was present on behalf of this item.

5. Budget Amendment for the COPS Tech Grant (first reading)

Mr. Martin stated the Sheriff's Department is requesting a Budget Amendment to establish a budget for the \$200,000.00 COP Grant awarded in 2009. Enough of the pieces of these projects are finally coming together to the point that there are contract negotiations on one and enough quotes on the other that he was able to establish a budget.

6. Budget Amendment for the E-911 Emergency Telephone (first reading)

Commissioner Elkin stated this is to cover the Centurylink services that were for the Emergency 911. Commissioner Elkin stated this is not the full amount but rather to cover the shortfall.
