The meeting was called to order at 9:30 a.m.

Sheriff's Department

Captain Chad Martin and Sergeant Brian Leer from the Sheriff's Department were present on behalf of this item.

1. Missouri Highways and Transportation Commission Blueprint for Safer Roadways Program Agreement (first reading)

Captain Martin stated that the Sheriff's Department is requesting Commission approval and signature of all three Commissioners on this agreement for grant money. Sergeant Brian Leer is present to answer any questions that the Commission might have. This particular one we will need to sign first and then send into the state for their requirements. County Counselor CJ Dykhouse had already approved and signed this.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

Purchasing Department

Tyson Boldan from the Purchasing Department was present on behalf of this item.

2. Bid Award for 52-18Nov10 Crushed Stone Aggregate and Chip Seal Product Term and Supply (first reading)

Mr. Boldan stated the Bid for Crushed Stone Aggregate and Chip Seal Product Term and Supply closed on November 18, 2010. Two bids were received. Purchasing and the Boone County Public Works Department recommend a dual award between Con-Agg of MO, L.L.C. and Mid-Missouri Limestone, Inc. For this bid, the distance between providers and the drop-off locations for aggregate affect the price. Boone County will receive the lowest and best possible price by awarding both providers and making orders according to the over

all cost while factoring in mileage expenses outlined in the bid responses.

This is a term and supply contract. Purchases from this contract will be paid from department 2040 – Public Works Maintenance Operations, Accounts 26200 – Rock and 262001 – Rock Vendor Hauled. \$1,200,000.00 is budgeted for this Term and Supply for the 2011 Year.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

3. Bid Award for 57-09Nov10 Elevator Maintenance Term and Supply (first reading)

Mr. Boldan stated the bid for Elevator Maintenance Term and Supply closed on November 09, 2010. Two bids were received. Purchasing, and Facilities Maintenance recommend award to Schindler for offering the lowest and best bid for Boone County. This is a term and supply contract. Invoices will be paid from department 6100 – Facilities Grounds and Maintenance and account 60050 – Equipment Services Contract.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

4. Bid Award 54-02Nov10 Fitness Equipment (first reading)

Mr. Boldan stated the Bid for the Fitness Equipment for the Sheriff's office closed on November 2, 2010. Seven bids were received. Purchasing and Sheriff Department recommend award by low bid as an "all or none" award to Healthline Inc. of Houston, Texas. Total cost of contract is \$11,562.05 and will be paid as follows:

\$11,450.00 - department 2550 - Sheriff Revolving Fund Activity, account 91300 - Machinery and Equipment.

\$112.05 - department 2550 - Sheriff Revolving Fund Activity, account 23850 - Minor Equipment and Tools.

The budget included the following:

\$20,150 / 2550 / 91300 \$3,870.00 / 2550 / 23850

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

5. Bid Award 49-15Nov10 Corrections Uniforms Term and Supply (first reading)

Mr. Boldan stated the Bid for Corrections Uniforms Term and Supply closed on November 15, 2010. Seven bids were received. Purchasing and the Sheriff's department recommend award to ED Roehr Safety Products for offering the lowest and best bid for Boone County.

This is a term and supply contract and invoices will be paid from departments 1255 – Correction and 2902 –Corrections – LE Sales Tax, account 23300 – Uniforms. \$20,000.00 is budgeted for department 1255 and \$5,652.00 is budgeted for department 2902.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

Kathy Lloyd the Court Administrator was present on behalf of this item.

6. Budget Amendment for the On Track Court Program (second reading, first read on 11/30/2010)

Ms. Lloyd stated she just wanted to bring attention to a couple of minor changes since the first reading. Ms. Lloyd stated they had miscalculated the disability insurance, the decimal was in the wrong place. Instead of \$152.00 the budget amendment is only \$16.00 and that is for one month. When I had presented previously I had given you a draft of the MOU but now you should have the signed final version of the MOU.

9. Change Order # 16 for the Sheriff's Annex & Warehouse Project (first and second reading)

Mr. Segefredo stated this is the addition for a dumpster pad that should be located between the existing jail and the Sheriff's Annex. The purpose of this is to prevent trucks from pulling up and rolling off the edge of the new pavement breaking off the edge of the new corner. The dumpster bed will help to prevent this. Mr. Segefredo stated they worked with the Sheriff's Department to ensure that this was located where they wanted it and ensured that this meets with city approval.

Commissioner Miller stated there is enough money in the contingency to pay for this.

Commissioner Pearson asked what was left in the contingency.

Commissioner Miller stated the \$25,000.00 that they will get back from Boone Electric for the geo-thermal system. The County can not get that money back until we actually install and hook them up. Commissioner Miller stated probably about \$4,000 or \$5,000 beyond that. Commissioner Miller stated there was a really tight contingency for this project.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby authorize Commissioner Karen M. Miller to sign Change Order #016 in the amount of \$12,656.00 for the Sheriff's Annex & Warehouse project.

10. Approval of the Parking Lot Lease with First Christian Church (first reading)

11. Approve Agreement with the City of Columbia to fund a three-quarter time position in Joint Communications to perform the enhanced 9-11 data entry duties (first reading)
