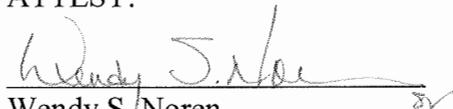

The four new cages are needed to replace one existing cage and I am installing the other three cages in patrol cars which currently do not have cages. We disposed of the Chevrolet Impala earlier this year. We were able to transfer all of the equipment, except for the cage. It will not work in a Ford Crown Victoria.

The three additional cages are for cars which currently do not have cages. The Civil Process deputies are responsible for all of the probate transports. I believe it is an officer safety issue and I would like to see cages in those vehicles. We presently have two cars without cages. We also have one vehicle in the Patrol Division which currently does not have a cage. The deputy, who inherited the car from a supervisor, would like a cage installed. Again, I would like to install a cage in that vehicle for officer safety reasons.

The Auditor's Office has received a payment request from the Sheriff's Dept for 4 security screens (\$1,040.00) and 9 Velcro leather belt keepers (\$170.19). Total cost = \$1,210.19. The request indicates these items are to be paid from Dept 2901 Sheriff Operations - Law Enforcement Sales Tax.

The original FY2004 fixed asset budget for Dept 2901 did not include these items. Therefore, our office cannot process payment until the County Commission has authorized these additions to the fixed asset budget.

We contacted the Sheriff's Dept to request additional information and let them know that a commission order would be required before payment could be processed. The Sheriff's Dept responded with the attached memo. I have also attached a spreadsheet showing the current status of Dept 2901 class 9 (fixed asset) budget.

We do not know if the Sheriff's Dept plans to contact the Commissioners or appear at a Commission meeting; we are simply forwarding our information to you. Please provide copies of this information to the Commissioners.

Our office will hold the payment request until the Commission has reached a decision.

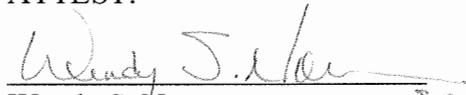

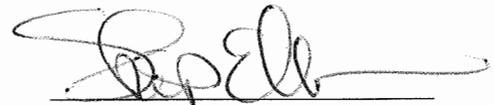

Dear Dr\*\*\*\*\*

We are in receipt of your billings for medical care of certain persons treated by you while prisoners at the Boone County jail. Under section 221.120 of the Revised Statutes of Missouri, the Sheriff is required to obtain necessary medical care for prisoners while in the custody of the sheriff, but obligates the prisoners themselves to pay for such care. However, the statute permits but does not require the county through its county commission to pay prisoner medical costs it determines to be reasonable and necessary. Although the county is under considerable budgetary constraints, the county commission recognizes that members of the medical community providing needed services to prisoners should not be placed in a position of providing medical care to prisoners without compensation. While the county limited in its ability to pay for prisoner medical expenses due to budgetary constraints, the Boone County Commission has determined after discussion with members of the medical community that it will pay for the costs of authorized and necessary prisoner medical care in amounts equivalent to current Medicare rates, which we understand is 36% of standard billed charges. Accordingly, we are enclosing a check to you based upon your billings which represents payment at this rate.
