The regular meeting of the County Commission was called to order at 9:32 a.m.

**SUBJECT: Planning and Building Inspection Department Budget Revision: Overtime**

Planning and Building Inspection Department Director Stan Shawver stated in preparing the 1996 budget for his department, Auditor June Pitchford was uncomfortable with his overtime projections. The amount was based on experience from 1995. Ms. Pitchford felt that with the addition of new employees, the overtime amount might stabilize. Ms. Pitchford now realizes his projections were fairly accurate and recommends the budget be revised at this time.

In response to a question from Commissioner Miller, Mr. Shawver replied the additional employees helped but did not eliminate the need for overtime. Adding an employee was discussed, but is not warranted at this time.

In response to a question from Commissioner Vogt, Mr. Shawver replied the employees do not mind working overtime.

Commissioner Miller moved that the County Commission of the County of Boone authorize the following budget revision:
