The regular meeting of the County Commission was called to order at 1:40p.m. by Commissioner Stamper.

**Subject: Reappointment of the Health Trust Board Members**

Commissioner Vogt stated Health Trust board reviews all the county health trust issues.

Commissioner Vogt seconded the motion.

**Subject: Medical Examiner purchase requisition**

Commissioner Stamper stated that many counties spend a great deal more money for this than we do. The requisition is in the amount of \$43,709. It is a contract between the University of Missouri and the County of Boone for the services of the medical examiner. Commissioner Stamper then moved to approving an agreement between the Curators of the University of Missouri and the County of Boone for medical examiner services and authorize the Presiding Commissioner to sign the purchase requisition.

Commissioner Miller seconded the motion.

The motion passed 3-0. **Order 388-98**

**Subject: Approval of Slate/Robertson Condemnation Settlement Agreement**

John Patton stated that the dispute boiled down to what extent the county should pay to replace one mile worth of fence. A compromise was reached on the eve of the trial where they would receive a \$6,000 lump sum. This occurred last spring and this had been agreed to one year ago. The money is available.

Commissioner Stamper moved to approve an agreement between Don Slate and Linn Robertson, property owners in the County of Boone, for a real estate acquisition in the County of Boone and authorize the Presiding Commissioner to sign.

Commissioner Vogt seconded the motion.

The motion passed 3-0. **Order 389-98**

**Subject: Change Order request for jail project**

Commissioner Miller stated that the architect wanted some money to study some of the heating, cooling and hot water systems in buildings C and D.

John Patton stated that this was not in the original contract.

Commissioner Vogt asked if the mechanical equipment of the jail was designed to handle more expansion.

John Patton stated that they did not build surplus capacity

Commissioner Vogt stated that each body produces 600 BTU's, and that could account for the need of extra cooling facilities.

Commissioner Miller stated that she thought this was important for the commission to know prior to renovation.

Commissioner Miller moved that the Boone County Commission modify the services from Schinkle Schultz to include a performance test by Woods Mechanical Inc. to be billed on a hourly basis and not to exceed \$3,875.

Commissioner Vogt seconded the motion.

The motion passed 3-0. **Order 390-98**

**Reports**

Commissioner Miller stated that the Commission Intern would do a presentation about Union Cemetery at the next meeting.

Commissioner Stamper stated that last Thursday he went to visit with Sid Powell and Don Sanders about a section of the Oregon Trail that goes through Boone County. The area is basically untouched and a grant is a possibility from the State Historical Society. He then suggested that the rest of the Commission to go out to look at it as most of the trail in other areas has been tilled over.
