Subject: Purchasing Department

Melinda Bobbitt, Purchasing Department Director, was present on behalf of these items.

A. Second Reading and Award of Bid 06-17FEB04 (Liberty Lane Project)

Melinda Bobbitt stated this is a recommendation for award to C. L. Richardson Construction Company for having the lowest and best bid meeting the minimum specifications. The total cost of the contract is \$507,395.45. The original budget was \$640,000.00.

Commissioner Miller moved to award bid 06-17FEB03 for the Liberty Lane Road Reconstruction Project to C. L. Richardson Construction Company.

Subject: First Reading of E911 Maintenance Agreement with Centurytel

June Pitchford, Boone County Auditor, was present on behalf of this item.

June Pitchford stated components of the E911 systems the County pays for out of the special tax are covered under a maintenance agreement. This is the same agreement that has been approved in prior years; however the schedule that is attached detailing the equipment has been revised.

There was no further discussion on this item.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

Subject: First Reading to Authorize County Auditor to Request Funds from Boone Hospital Board of Trustees

June Pitchford, Boone County Auditor, was present on behalf of this item.

Commissioner Schnarre stated this is a letter that June Pitchford will be sending to the Hospital Board of Trustees requesting \$500,000 for the Health Facilities.

June Pitchford stated it was requested to her that there be a Commission Order approving the letter to the Board of Trustees.

Commissioner Elkin stated the County is at a stage of construction where the funds are needed to pay some costs.

There was no further discussion on this item.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

Subject: First Reading of Inmate Medical Costs

June Pitchford, Boone County Auditor, was present on behalf of this item.

June Pitchford stated her office is holding pending invoices that total approximately \$177,000 in inmate medical bills. In the past, the Sheriff's office had returned bills directly to vendors; not charging those costs to the County and this policy was changed in 2003 but was not detected until March 2003. At that time, she, the Sheriff, Commissioner Schnarre and some of the Corrections staff began a series of meetings with various hospital administrators and community health professionals to try to work through some solution. The outcome of those efforts is a letter agreement with all the vendors appearing on the list.

Mrs. Pitchford read the letter for the record.

Mrs. Pitchford reviewed the funds set aside for inmate medical costs for 2004, which amount to approximately \$500,000. In addition, the Trustees have pledged funding for an additional position, approximately \$65,000. The Sheriff has requested funding from contingency for the additional 2 hours per week for the part-time position. The 2004 budget includes the costs being discussed today.

The Auditor's office did research on Medicare and Medicaid rates and how those rates would affect the bills. Of the medical bills from Boone Hospital, Medicaid would have paid 24% and Medicare 28%, an average of 26%. The County has used 26% in the two letters to the hospitals. The research the Auditor's office did on Medicare and Medicaid rates for physicians showed a 33% average rate. Those are the amounts in the proposed letters of agreement.

During the meetings, the medical professionals had informed the County they would like the County to work on a global solution, which means having the County do as much as possible on-site to screen out situations that result in unnecessary trips to emergency rooms. The Sheriff and his staff will be consulted on procedures for this.

Mrs. Pitchford stated she and John Patton, County Counselor, worked together on the letter agreement and he prefers the County to move this to a formal contract as a long range goal.

The amount of additional funding that would be needed, were the letter agreements to be approved and accepted, is reflected in the budget revision, in the amount of \$63,346. These funds will be transferred from class one line items.

Commissioner Schnarre noted there is a difference between the budget revision and another amount.

Mrs. Pitchford noted currently class eight is in the whole by \$15,000 because there were certain bills that had to be paid out of class eight.

There was discussion about the proposed percentage rates.

Commissioner Miller noted NACo is working with Congress to pass a bill to allow for inmates to keep their medical coverage until the inmates are sentenced. Currently, inmates lose coverage as soon as they are put in jail.

There was no further discussion on this item.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

Subject: Authorize Use of County Facilities – Columbia Festival of the Arts

Commissioner Miller moved to authorize the use of Boone County Facilities as requested by the City of Columbia Office of Cultural Affairs for the Columbia Festival of the Arts between 4:00 p.m. September 24, 2004 and 8:00 p.m. September 26, 2004.
