The meeting was called to order at 9:33 a.m.

Health Department

1. Abatement of a property located at 501 N East Park Lane, parcel # 17-320-12-01-024.00 01 (first and second reading)

Environmental Health Manager Kala Gunier was present on behalf of this item. Ms. Gunier stated this is out in Sunrise Estates, and appears to be vacant. Ms. Gunier stated the owners live in Fulton, and she found a phone number, but it was disconnected. Ms. Gunier stated she gets a complaint a week about this property. Ms. Gunier there is no sign it is going through the foreclosure process. Ms. Gunier stated she thinks they used to rent this place out, because she has received trash complaints in the past. Ms. Gunier stated the bid to mow it is \$100; it's pretty tall. Ms. Gunier stated it's probably a fire hazard.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby authorize the Presiding Commissioner to sign the attached Finding of Public Nuisance and Order for Abatement of a public nuisance located at 501 N East Park Lane (parcel # 17-320-12-01-024.00 01).

2. Abatement of a property located at 4850 E Leora Lane, parcel # 12-204-10-03-001.00 01 (first and second reading)

Environmental Health Manager Kala Gunier was present on behalf of this item. Ms. Gunier stated this is one we abate every year; the owner doesn't live here. Ms. Gunier stated the owner lives somewhere overseas.

Commissioner Atwill stated we're just the mowing service.

Commissioner Elkin stated they partially built the house, but never finished it. Commissioner Elkin stated the County Counselor is trying to work with the owner.

Commissioner Atwill asked if this is the guy that had an electronic business.

Commissioner Elkin stated yes.

Commissioner Atwill stated he sued him once.

Ms. Gunier stated the County mows his property every year; the bid for this year is \$150.

Commissioner Miller stated we've talked about trying to find a way to charge more for these chronic nuisances.

Ms. Gunier stated after we charge our \$150 administrative fee, it's only \$300. Ms. Gunier stated that's a pretty cheap mowing service for the year.

Commissioner Atwill asked if it goes on his lien.

Ms. Gunier stated it goes on their real estate taxes. Ms. Gunier stated she thinks the owner acquired the property off of a tax sale.

Commissioner Atwill confirmed we can't charge more than what it costs us to administer it. Commissioner Atwill asked what we need to do to ratchet the cost up.

Commissioner Miller stated we need to change the law.

Commissioner Elkin stated if we were a charter we could do it.

Commissioner Miller stated we need to speak with the County Counselor about civil fines on chronic nuisances.

Ms. Gunier stated there may be six in the County.

Commissioner Miller stated there would be fewer if there was a fine.

Ms. Gunier stated we've abated this every year we've abated nuisances, which started in 2006.

Ms. Vellema stated they sent someone out with a sump pump and emptied out a lot of water, but there is still about 18 inches of water in the bottom. Ms. Vellema stated she can't get them to finish the job. Ms. Vellema stated we would like to just dismantle it in some fashion so it doesn't hold water anymore.

5. Bid award to Neumayer Equipment Company for bid 25-02MAY12 – Fuel Dispensers Removal and Installation (first reading)

The Bid for Fuel Dispensers Removal and Installation closed on March 17, 2012. Three bids were received. Purchasing and the Public Works Department recommend award to Neumayer Equipment Company, for offering the lowest and best bid for Boone County.

The Bid Amount of \$24,685.00 includes the mobilization, all work required, and the materials cost. After including a 10% contingency amount of \$2,468.50, this project has a Boone County Purchase Order total of \$27,153.50. Invoices from this contract will be paid from department 2040 - PW - Maintenance Operations, account 92300 - Replacement Machines and Equipment. \$134,697.94 is left in this account at this time.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available Commission meeting with an appropriate order for approval.

6. Amendment number one to bid 62-23NOV09 – Office Supplies Term and Supply (first reading)

Contract 62-23NOV09 – Office Supplies Term and Supply was approved in commission on December 15, 2009 on commission order 581-2009. The attached amendment clarifies that monthly statements (not invoices) will be paid within receipt of thirty days.

This is a County-wide term and supply contract.

7. Cooperative Contract: 116/2011 - Bituminous Material (first reading)

Purchasing and Public Works request permission to utilize the City of Columbia contract 116/2011 - Asphalt Term and Supply.

These contracts will allow Boone County to receive City of Columbia pricing for asphalt products from Christensen Asphalt and American Materials under Boone County's Terms and Conditions until July 31, 2013. There are three, one-year optional renewals.

Invoices from these Term and Supply contracts will be paid from Department 2040 – Public Works Maintenance Operations, account 26000 – Pavement Repair Materials. \$174,955 remains in the budget at this time.

Ms. Bobbitt stated we already approved the contract for APAC last year, but we're getting them all under one contract.

8. Bid award to Midway Ford Truck Center for bid 22-20JUN 12 – Ford F550 Sign Truck (first reading)

The Bid for 22-20JUN12 - Sign Truck opened on June 20, 2012. Three bids were received. The low bid of \$41,351.52 was offered by Midway Ford Truck Center, but they sold the truck before we awarded the bid. Recommendation for award is the next lowest and best bid which is also Midway Ford Truck Center of Kansas City, Missouri.

Cost of truck is \$43,472.00 and will be paid from department 2040 –account 92400 – Replacement Auto / Trucks. A Budget Amendment has been prepared by Public Works to cover the cost of this truck.

Public Works requests permission to dispose by auction on GovDeals a 2005 CHV4500 Cab/Chassis Truck with Service Body, fixed asset tag 15216, VIN number 1GBJK342X5E295571.

Ms. Bobbitt stated this truck that costs more has a bed on it that we don't need, and Greg said we can sell it on GovDeals.
