Commission

2. Proclamation Recognizing May 5th-11th 2024, as International Compost Awareness Week

Commissioner Aldred read the following Proclamation:

- Whereas, composting is a proven method of returning organic resources to the soil; of conserving water during extreme drought or flooding; of decreasing erosion; and of decreasing dependence on artificial chemical fertilizers; and
- Whereas, composting is an effective means of reducing, reusing, and recycling waste and, since organic materials make up approximately 30% of the material going to landfills, composting is becoming one of the primary methods communities use to reach waste diversion goals; and
- Whereas, materials such as yard trimmings, vegetable cuttings, food scraps, biosolids, manures, and hay shavings are all compostable and thus are converted into the beneficial product known as compost; and
- Whereas, composting creates local green jobs and infrastructure for cities and states that implement composting programs; and

Whereas, by using compost for public works projects, communities and their local governments, highway departments, soil conservation services, extension offices, and public works professionals can have a significant impact on clean water, soil quality, climate change, and landfill diversion; and

- Whereas, May 5 May 11, 2024, is recognized as International Compost Awareness Week, declared as such by the Compost Research & Education Foundation; and
- Whereas, International Compost Awareness Week is an awareness and educational initiative intended to showcase compost production and demonstrate compost use; and

- Whereas, the 2024 theme, COMPOST...Nature's Climate Champion, highlights the role compost plays in fighting climate change, such as decreasing methane, helping with climate change mitigation, reducing fertilizer inputs, and increasing resilience.
- Therefore, the Boone County Commission, in recognition of the efforts of the Compost Research & Education Foundation, extension agents, soil conservation stewards, landscapers, farmers, recyclers, public workers, gardeners, plant growers, and all composters everywhere, hereby proclaim the week of May 5-11, 2024, as International Compost Awareness Week.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby enter into the record a Proclamation Recognizing May 5-11, 2024, as International Compost Awareness Week.

Commissioner Thompson seconded the motion. The motion carried 3 to 0. **Order #214-2024**

3. Proclamation Recognizing May 2024 as Mental Health Awareness Month

Commissioner Thompson read the following Proclamation:

- Whereas, mental health is an essential part of every person's overall well-being, encompassing the emotional, psychological, and social health of each person, as well as their families and communities; and
- Whereas, a person's mental health influences their thoughts, feelings, and actions; impacts how they handle stress, relate to others, and make choices; and affects their overall ability to function, grow, and thrive; and
- Whereas, like physical health, a proactive approach to maintaining mental wellness and a willingness to seek help when struggling with mental health issues will result in better long-term outcomes both for individuals and for the community as a whole; and
- Whereas, everyone faces challenges in life that can impact their mental health and, each year in the U.S., 1 in 5 adults experience mental illness and 1 in 25 adults experience a serious mental health condition; and

- Whereas, 50% of mental health conditions present themselves by the age of 14, resulting in 1 in 6 U.S. youth experiencing mental illness and, sadly, suicide being the second-leading cause of death among people ages 15-24; and
- Whereas, despite its prevalence, mental health remains shrouded in stigma, leading to fewer than half of those diagnosed receiving treatment for mental illnesses; and
- Whereas, growing awareness of and support for mental health in our community helps to challenge the stigma surrounding mental illness, resulting in a community more educated in this vital aspect of each person's health, which can lead to higher overall productivity, better educational outcomes, stronger economies, and improved quality of life; and
- Whereas, all individuals who have mental health challenges can achieve recovery; and
- Whereas, Boone County is dedicated to advocating for mental health and those living with mental illness by actively supporting local efforts devoted to childhood mental health; participating in initiatives focusing on justice-involved individuals living with mental illness; and collaborating with other counties to raise awareness of and develop systems to address suicide risk, especially in rural communities.
- Therefore, the Boone County Commission does hereby recognize May 2024 as Mental Health Awareness Month and encourages everyone to celebrate the 2024 theme of Where to Start: Mental Health in a Changing World by prioritizing mental well-being in a changing world and taking action to find new resources to navigate and thrive amid the various changes and challenges surrounding us.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby enter into the record a Proclamation recognizing May 2024 as Mental Health Awareness Month.

Boone County Sheriff's Office

4. First Reading: City of O'Fallon, Missouri Police Department K-9 Basic Training Agreement

Captain Brian Leer stated in 2023, the City of O'Fallon reached out to the Sheriff's Office to get a quote to train a handler and a new K-9. Captain Leer stated the Agreement is for not less than 40 sessions and in the amount of \$4,000.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Boone County Joint Communications

5. First Reading: Budget Revision - Department 2704 - Cover Class 9 Ops Room Chairs

Major Gary German stated during the budgeting process, the chairs for the operations room were not incorporated into the budget. Major German stated they have gotten a quote for the chairs, and they have some savings from the radio budget they would like to move over to cover the cost of the chairs.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Boone County Resource Management

6. First Reading: Approval of Stormwater Security Agreement and Erosion and Sediment Control Cash Deposit for Midwest Electronic System

Stormwater Security Coordinator Nicki Rinehart stated this is for the construction of a 6,000 square foot building that will have office space, warehouse space, parking, and stormwater infrastructure. Ms. Rinehart stated they have submitted a cash deposit in the form of a cashier's check in the amount of \$57,786.31 to cover 160% of the erosion and sediment costs. Ms. Rinehart stated once the site has been fully stabilized, the deposit will be refunded.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

7. First Reading: Recommendation for Stop Sign Installation Reams Road at Rob Cook Road and Zaring Road at Rob Cook Road

Chief Engineer Jeff McCann read the following memo:

A site visit was conducted at the four-way intersection of Rob Cook Road, Reams Road, Zaring Road, and Durk Road, based on a phone call from a concerned citizen. The intersection is located northeast of Columbia and is approximately 0.77 miles east of the Route Z and Route

HH intersection. Rob Cook Road and Durk Road are oriented east-west, and Reams Road and Zaring Road are oriented north-south as shown on the attached sketch.

The intersection is currently controlled by yield signs on the Reams Road approach leg and on the Zaring Road approach leg. The Rob Cook Road and Durk Road approach legs are uncontrolled. Average daily traffic (ADT) counts for Rob Cook Road, Reams Road, Zaring Road, and Durk Road are 296, 108, 86, and 83 respectively. All four roads are posted at a 35 MPH speed limit.

Site distance is limited at the northwest and southwest corners of the intersection due to trees on private property and a slight embankment. AASHTO design guidelines recommend a sight distance triangle with 140' minimum leg lengths for low volume intersections posted at 35 MPH. The sight distance leg lengths for Reams Road and Zaring Road are below the minimum. I recommend replacing the existing yield signs (R1-2) on Reams Road and Zaring Road, with stop signs (R1-1) based on the limited sight distance and current traffic volume.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. First Reading: Amendment #1: C000723 – The Shops at Sharp End with Central Missouri Community Action

Director of Purchasing Melinda Bobbitt read the following memo:

Contract C000723 – "The Shops at Sharp End" was approved by Commission for award to Central Missouri Community Action (CMCA) on February 8, 2024, Commission Order 65-2024.

This Amendment authorizes CMCA to charge a 14% indirect cost surcharge to their ARPA invoices pursuant to that agency's indirect cost rate agreement that is in place for all federal grants.

Invoices will be paid from Department 2983 - American Rescue Plan Act, Account 84200 - Other Contracts. \$21,422,312 is budgeted for the ARPA contracts.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

WHEREAS, the Boone County Planning and Zoning Commission conducted three (3) public hearings, after due public notice, into the issue of re-adoption of the Boone County Zoning

Regulations, Sections 1 through 30. This includes revisions to Section 2, Definitions, Section 15 Administration, and adoption of Section 30 Solar Energy Overlay District (SEOD); and

WHEREAS, the Boone County Planning and Zoning Commission (P&Z) has recommended that the County Commission readopt those regulations including revisions to Section 2, Definitions, Section 15 Administration, and adoption of Section 30 Solar Energy Overlay District (SEOD); and

WHEREAS, the County Commission conducted a public hearing on re-adoption of those regulations on April 9, 2024; and

WHEREAS, all required notices have been given and all required public hearings have been held;

NOW, THEREFORE, the County Commission of the County of Boone does hereby adopt the Boone County Zoning Regulations Sections 1 through 30. This includes revisions to Section 2, Definitions, Section 15 Administration, and adoption of Section 30 Solar Energy Overlay District (SEOD), copies of which are attached and incorporated by reference along with the following attachments:

1. Notice of the first Planning and Zoning Commission hearing, affidavit of newspaper publication, affidavit of posting in the Boone County Government Center, and the hearing minutes.
