The meeting was called to order at 1:30PM and roll call was taken.

Boone County Clerk

1. First Reading: Budget Amendment – Department 2320 – Election Equipment Replacement Fund

Boone County Clerk Brianna Lennon stated her office has been working very hard to make the efficiency improvements they have learned about from other places, with one of those things being to introduce a ballot on-demand system. Clerk Lennon stated this would allow the central polling locations, and during absentee voting, to give the specific precinct style ballot as opposed to their central face. Clerk Lennon stated, when you look at the election results, "absentee" is their own precinct and "central polls" are their own precinct. Clerk Lennon stated they can't tell someone, if they ask, of all the people that voted absentee, how many came from the first ward? "We can't break that down any farther." Clerk Lennon stated the reason for that is because to do that, they would have to have every single ballot style available at the central polls and poll workers would have to wade through 90 different ballot styles to give a person the

correct one. Clerk Lennon stated now they will not need to; she is going to purchase ballot on demand equipment which will allow staff to print the ballots as a voter gets checked in, so every voter gets their own special ballot. Clerk Lennon stated this will save on the cost of preprinting ballots and the efficiency of having to sort through that many ballots. Clerk Lennon stated she has the money in the Election Equipment Replacement Fund which is a statutory fund through Chapter 115 for the County Clerk's Office. Clerk Lennon stated she is here today to request the use of those funds to make the purchase.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. First and Second Reading: Request to Hire Above the Flexible Hiring Range for Position 500, Victim Assistant, Prosecuting Attorney's Office

Presiding Commissioner Kip Kendrick stated this request is to hire a Victim Assistant for the Prosecuting Attorney's office. Commissioner Thompson stated the candidate looks to be very well-qualified for this position, having a Bachelor's in psychology with a minor in child and family studies. Commissioner Kendrick stated there are no equity concerns, and there will be no budget impact.

Commissioner Thompson stated he told her at one point that he had been in the army in WWII and served in the tank division and was in the Battle of the Bulge, which took place in a very cold and snowy December. Commissioner Thompson stated that battle lasted for several days, and they slept in the tanks, which were unheated and damp. Commissioner Thompson stated the man said he lost his toes to frostbite, and that always stuck with her. Commissioner Thompson stated many sacrificed their lives, and other sacrifices also happened throughout that war to maintain freedom in the world. Commissioner Thompson stated many gave all, and many gave some, and we are indebted to all.
