2. First Reading: Contract: C000784 (09-19APR24) - Planning and Implementation Services for the Greater Bonne Femme Watershed Initiative and Watershed-Based Plan

Buyer Amy Gerskin read the following memo:

Request for Proposal 09-19APR24 - Planning and Implementation Consulting Services for the Greater Bonne Femme Watershed Initiative and Watershed Based Plan closed on April 19, 2024. One bid response was received by Geosyntec Consultants, Inc.

The Evaluation Committee consisted of Lynne Hooper, Resource Management, Urban Hydrologist, and Nicki Rinehart, Resource Management, Stormwater Coordinator. The recommendation from the Evaluation Committee is to award the contract to Geosyntec Consultants, Inc. The county contract number is C000784.

The total cost of this contract is \$147,400.00. Any additional expenses will require a contract amendment.

The budgeted cost of the contract is \$150,000.00, and funds will reference Departments 1725 - General Fund Resource Management Stormwater Planning and 2046 - Road and Bridge Resource Management Stormwater Planning, account 71100. Attached for reference is the bid tabulation.

Boone County, Missouri received ARPA grant funding from the federal government and the County Commission engaged in an RFP process to determine ARPA funding awards.

This ARPA award is for County contract ARPA Funding Subrecipient: C000801 – Bear Creek Affordable Housing Project with the Housing Authority of the City of Columbia, a municipal corporation of the State of Missouri. The funds will be used to support the Housing Authority of the City of Columbia in expanding and renovating their Bear Creek affordable housing community, renovating community facility space, and updating security. The funds will be used to renovate existing housing units, convert existing facility space into housing, resulting in additional housing units on site. The Bear Creek affordable housing community serves low-income families, with 68% of the families falling at or below 30% of the area median income.

Contract award is for a not-to-exceed amount of \$835,000.00, and will be paid from department 2983 – American Rescue Plan Act, account 84200 – Other Contracts.
