The meeting was called to order at 1:30PM and roll call was taken.

Boone County Sheriff's Office

1. First Reading: Howell County Sheriff's Department K-9 Basic Training Agreement

Captain Brian Leer stated this contract is to train a new dog and handler for an 8-week course, not less than 40 sessions, in the amount of \$4,000.00. Captain Leer stated this would include a 1-year Maintenance Agreement as well.
