The meeting was called to order at 1:30PM and roll call was taken.

### **Boone County Sheriff's Office**

1. First Reading: Budget Revision - Department 2901 & 1255 - Cover Class 9 & Class

Captain Brian Leer stated this request is to move funds from Account 2900 to Account 2901 and Account 1255 for the purchase of mobile radios and associated equipment. Captain Leer stated this is for a total of fourteen radios. Captain Leer stated this revision is for \$101,046.00. They are asking this amount to be moved from contingency to 2901 and 1255 split up to cover the purchases.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

### **Human Resources**

2. First and Second Reading: Request to Reclassify Position 765, Administrative Technician II to Administrative Assistant, Road & Bridge

Director of Human Resources Angela Wehmeyer stated this request is to reclassify position 765 from a range 25 to a range 22. Director Wehmeyer stated there will be a cost savings since the range will be lowered. Director Wehmeyer stated the Director of Road & Bridge and members of Human Resources completed an analysis of the administrative positions at Road & Bridge and decided this current vacant position needed some of the higher-level job functions to move to their current Administrative Coordinator position, and some of the entry level functions of the Administrative Coordinator position will move to this new classification.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby authorize the request to convert position 765, Administrative Technician II (Class Code 101601, Range 25), to Administrative Assistant (Class Code 101400, Range 22).

# **Boone County Counselor**

3. First Reading: Acknowledging receipt of the annual financial report from the Centralia Special Road District (CSRD)

Boone County Counselor CJ Dykhouse stated any special road district within a County must file financial information with the County Commission during the month of August. Counselor Dykhouse stated Treasurer Anthony Kendrick of the Centralia Road District provides his office this information earlier in the year when he files it with the state auditor's office, but, pursuant to state statute, the County waits until August to begin the process of the Commission acknowledging receipt of the information.

# **Purchasing**

4. First and Second Reading: Award of Contract C000838 from cooperative contract NASPO #00318 for Public Safety Communications Products, Service and Solutions from Daniels Electronics LTD. dba Zetron, a Codan Company for the Boone County Joint Communications Department

Senior Buyer Liz Palazzolo read the following memo:

Purchasing requests approval of contract C000838 using NASPO contract #00318 for Public Safety Communications Products, Service and Solutions set up for the County's cooperative use via Participating Addendum by the State of Missouri. The County will be purchasing fourteen MT5 radios with related equipment. The total purchase will be \$68,203.80 with a credit that will be applied to the final invoice for \$29,644.00 for the return of 29 paging cards previously purchased by the County. The credit represents 60% of the original value of the paging cards. The final invoice will be \$38,559.80.

It is noted for the record that the paging cards do not have asset tags and for this reason there is no associated Surplus Disposal form.

Payment will reference 2706 – Boone County Joint Communication Radio Improvements/91300 – Machinery & Equipment: \$68,203.80.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the award of County Contract C000838 from cooperative contract NASPO #00318 for Public Safety Communications Products, Service and Solutions from Daniels Electronics LTD. dba Zetron, a Codan Company of Redmond, Washington for the Boone County Joint Communications Department.

The contract is set out in the attached and the Presiding Commissioner is authorized to sign the same.

#### **Juvenile Justice Center**

5. First and Second Reading: Building Local Continuums of Care to Support Youth Success Grant Proposal

Juvenile Justice Center Superintendent Tara Eppy stated this grant is through the Office of Juvenile Justice and Delinquency Prevention and sought to continue the process after the sequential intercept mapping (SIM) process that Boone County will be doing, which is a youth specific SIM they will be engaging in during the fall. Superintendent Eppy stated this grant is to support the recommendations coming out of the SIM to build transition and re-entry for the youth involved with the justice system. Superintendent Eppy stated this includes a total of \$302,337.00 for the request, and includes a lead continuum person and two support staff, who would be working in conjunction with the Commission and the Children's Services Board to help create the continuum of services for youth when they are re-entering the community. Superintendent Eppy stated this is an 18-month grant.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve the attached Office of Juvenile Justice and Delinquency Prevention - Building Local Continuums of Care to Support Youth Success grant proposal submitted by the 13th Judicial Circuit, Family Court -- Robert L. Perry Juvenile Justice Center.

# 11. Commissioner Reports

Commissioner Kendrick stated he would like to thank the Boone County Collector and Collector's office for processing one month of real estate property tax relief program applications. Commissioner Kendrick stated he doesn't know the exact number, but he knows they are above 2,300 applications at this point. Commissioner Kendrick stated while they have been implementing and streamlining a complex program, they have done it very well and have been very helpful in answering questions and moving seniors through the process quickly. Commissioner Kendrick stated he read an article from St. Charles County about the difficulty they've seen, and how they have a 42% rejection rate of applications, and five-hour waits at their Collector's windows just to get things through. Commissioner Kendrick stated this process has been a challenge for Collectors' offices across the state, so "hats off" to our Collector Brian McCollum and his staff doing a tremendous job.

Commissioner Thompson stated when people are hearing those kinds of numbers, even more counties will be asking to use the model that's being used in Boone County. Commissioner Thompson stated through the Missouri Association of Counties and through the Collector's Association, everyone has heard about this program and asking for guidance on how Boone County is doing it because our Collector is doing it so well. Commissioner Thompson stated they have had great help from our Assessor and Recorder of Deeds and from the County Counselor. Commissioner Thompson stated Counselor CJ Dykhouse has presented to the Collectors' Association and will be presenting to the Missouri Association of Counties about how this process can be handled.
