
Geography Standards, 1994: 18). Geography, however, is not limited to the global scale; local-scale geography is just as important to our understandings of ourselves and our larger world.

Memorandum of Understanding

1. This Agreement between Youth Community Coalition (YC2) and

Boone County Sherriff's Department shall be from October 1, 2015 until September 30,

2016, or until terminated by mutual agreement:

SERVICES AND RESPONSIBILITIES

- 2. YC2 shall be responsible to:
 - a. \$6,000 from the STOP ACT Grant to be used between October 1, 2015 through September 30, 2016.
 - b. Distribute positive rewards to retailers who pass compliance checks.
- 3. Boone County Sherriff's Department shall be responsible to:
 - a. Conduct a minimum of 15 compliance checks between October 1, 2015 and September 30, 2016;
 - Provide a report to Youth Community Coalition indicating the number of compliance checks performed and the number of passed/failed checks.

CONFIDENTIALITY

Both parties agree that they shall be bound by and shall abide by all applicable Federal or State statutes or regulations pertaining to the confidentiality of client records or information, including volunteers. The parties shall not use or disclose any information about a recipient of the services provided under this Agreement for any purpose not connected with the parties' contract responsibilities, except with the written consent of such recipient, recipient's attorney, or recipient's parent or guardian.
