City of Columbia Consolidated Plan

The City of Columbia receives Community Development Block Grant (CDBG) and Home Investment Partnership Program (HOME) funding annually from the Department of Housing and Urban Development (HUD). The City of Columbia is required to submit a Consolidated Plan at least every five years in order to qualify for funding. The Consolidated Plan is a comprehensive plan outlining affordable housing and community development needs and strategic implantation strategies for expenditure of CDBG and HOME funds, as well as funds allocated to the Columbia Public Housing Authority, Continuum of Care funding, the Missouri Housing Development Commission (MHDC) and any available local housing funds. The City is currently operating in the final year of the FY 2020-2024 Consolidated Plan and is in the final stages of completing the next, five-year plan. The FY 2025-2029 Consolidated Plan will act as a guiding document for the City's investment in affordable housing and community development efforts for the five years. City of Columbia Conservation District Overlay Project

The City has engaged a planning consultant to study the diverse collection of neighborhoods surrounding downtown and the college campuses in order to establish urban conservation ordinances and design guidelines that protect the character of these central neighborhoods while promoting comparable growth and development. The draft vision statement for the project states "the Central Columbia Urban Conservation District will guide contextually-sensitive development, better connect residents to community amenities, and promote reinvestment to strengthen the unique character of the neighborhoods while improving the social capital and quality of life for all residents, no matter their age, income, or ability." 2023 Columbia/Boone County Community Health Assessment

Columbia/Boone County Public Health and Human Services (PHHS) and its community partners conducted a Community Health Assessment (CHA) using the Mobilizing for Action through Planning and Partnerships (MAPP) process. The process included analysis of primary and secondary data. Within the CHA there is a Built Environment Assessment. Built environment is the human-made setting that influences the overall health of a community, including individual behaviors that affect health (CDC, 2022).
