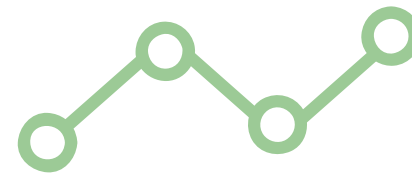

FORUM OVERVIEW

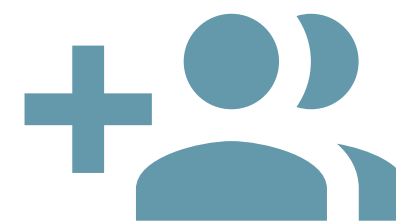
The Boone County Children's Services Board (BCCSB) hosted a forum in June 2019 to get recommendations from community members on coordinating a conference to address youth violence. To set the stage, a brief presentation was provided covering the following information:



Risk factors of youth violence identified by the Center for Disease Control and Prevention (CDC)



Local data on arrests, juvenile justice, referrals, drug/alcohol use, school discipline, poverty, and mental health



Protective factors that mitigate risk of violence in families and communities identified by the CDC

If our collective effort was to develop an action plan around only ONE of the top issues that emerged from pre-forum survey or local data, which issues would you prioritize and why?

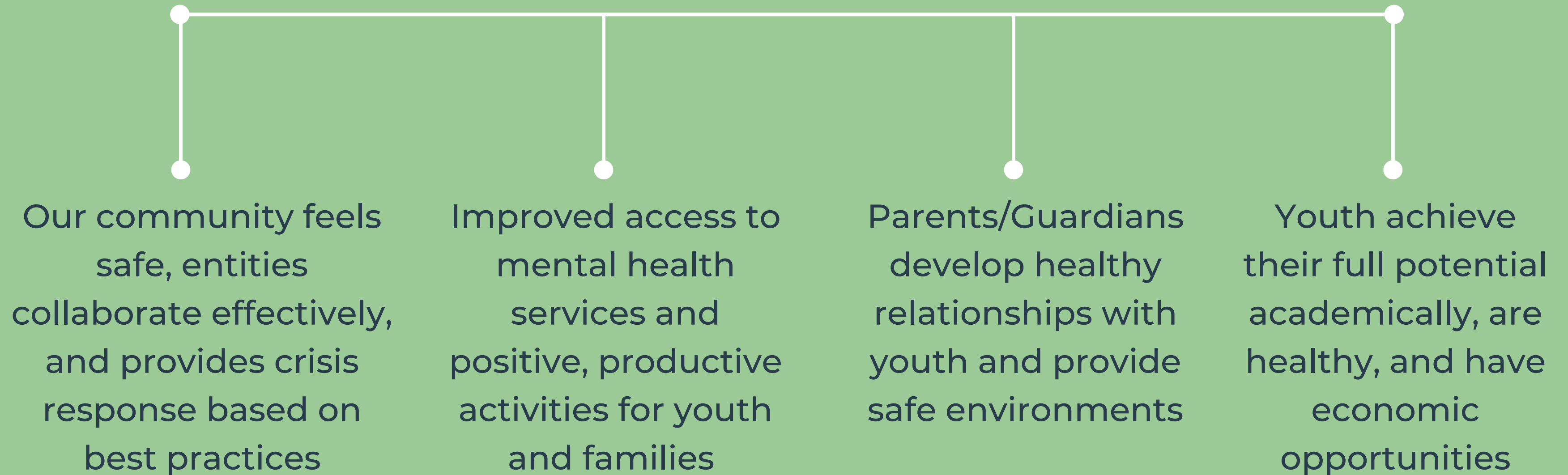

PLANNING COMMITTEE DELIVERABLES

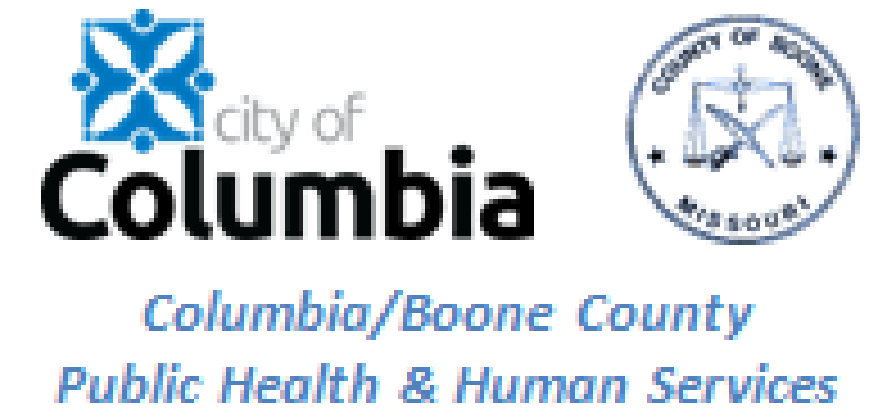
- 1** Presentations will cover the impact of violence and trauma on youth

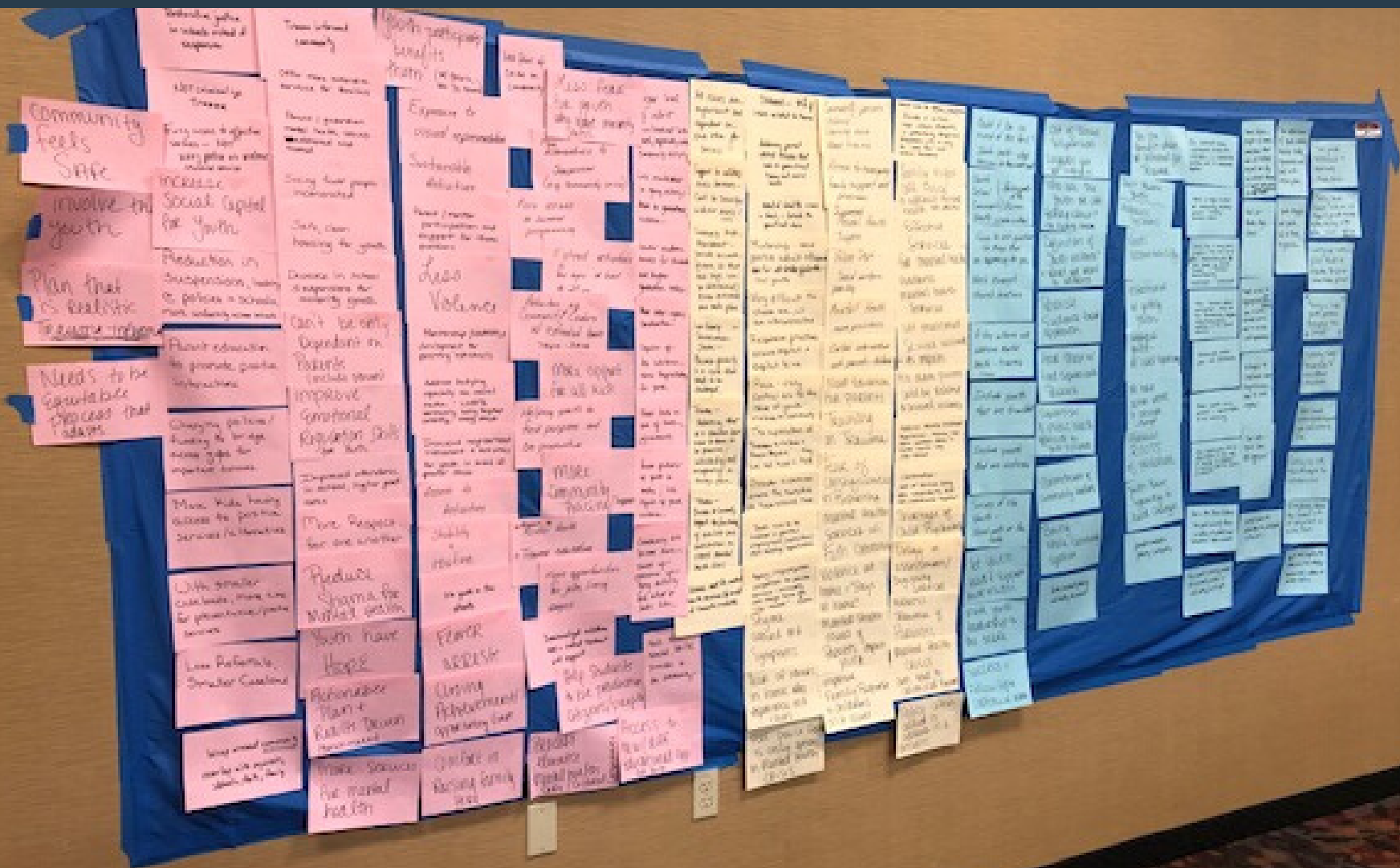
