- 1. Welcome and Introductions: Al Plummer opened the meeting with introductions. He shared that Lenna Peterson is leaving BCCSD & this was her last meeting. Lenna shared thanks and appreciation for the experience of working together.
- 2. Discuss Status of Outreach to Boone County School Districts
  - a. Status update on contact with Boone County superintendents Verna shared that she was able to meet with Boone County Superintendents after meeting with Sara Owens, Director of School Based Services for FACE. Verna introduced the Upward Mobility Early Grade Literacy Workgroup to the Boone County Superintendents and asked for the opportunity to meet one on one to discuss their greatest challenges and what they would like to celebrate. They were open to meeting with Verna. Lara Wakefield shared additional information for the workgroup in a document that will be emailed with the March meeting minutes.
  - b. Outreach planning Al Plummer opened the group discussion requesting from the workgroup, what, exactly, is the information we want from the Superintendents?
    - i. Draft questions for superintendents The group came up with a detailed list of questions including some addressing federal and state funding for current student supports i.e., after school tutoring programs funded by ARPA funds. What will happen to those supports after funding is exhausted?
