Results Statement: All children in Boone County learn to read and write and see themselves as readers and writers.

- 1. Welcome and Introductions Al Plummer welcomed everyone to the meeting followed by introductions
- 2. Action Step Update: Help families feel comfortable seeking support
 - a. Boone County school districts outreach
 - Al shared he and Verna had a successful meeting introduction with Southern Boone District Superintendent, Tim Ross and Asst Superintendent Jake Watson. Jake will follow up with scheduling/connecting us with their School Improvement Coordinator/Curriculum Director and Literacy coach. Verna has reached out to all Boone County Superintendents for meetings and follow up meetings for those we have already met with.
 - b. Continued outreach and collaboration efforts The group thought of Head Start locations as a source for outreach, which includes locations in Centralia and Columbia. Jenrose offered connections into Centralia and Sturgeon areas.
- 3. Evaluate potential action steps with a focus on ages 0-5
 - a. With our new focus, who is missing from the table and how do we reach them? Jenrose proposed that licensed childcare providers could open the conversation to unlicensed childcare providers. Community messaging and campaigns could be an effective way to touch base with those groups. Verna mentioned that the Boone Co Community Health Workers are in the community completing health assessments all over Boone County and could be a great referral source. Jay-Dee Bush is their supervisor and would be a good contact to coordinate and collaborate with them. It was proposed to see what, if any, literacy questions are on assessments.
 - b. Gay suggested looking at former programs, such as the "Play, Hug, Read" program, and see about revamping them with parent input.
