RE: Award of Contract C000783 from RFP 05-13MAR24 for Detainee Medical Services for the Boone County Jail/Boone County Sheriff - Term and Supply

Purchasing requests approval of Contract C000783 that results from Request for Proposal 05-13MAR24. Said RFP solicited proposals for Detainee Medical Services for the Boone County Jail. Four proposals and one "No bid" were received:

- (1) Advanced Correctional Healthcare of Franklin, Tennessee
- (2) Turn Key Health Clinics LLC of Oklahoma City, Oklahoma
- (3) Vital Medical Services of Glendale, California
- (4) Superior Blessings LLC of Columbia, Missouri
- (5) Southern Health Partners of Chattanooga, Tennessee (No Bid)

The four proposals have been reviewed by an Evaluation Team that consists of the following personnel: Captain Damon Reynolds, Boone County Jail Administrator; Captain Brian Leer of the Boone County Sheriff's Office; Captain Jenny Atwell, Assistant Boone County Jail Administrator; and Leasa Quick, Budget Administrator for the Boone County Sheriff's Office. The Purchasing Department chaired two evaluations meetings with the Evaluation Team and conducted two rounds of negotiations.

After the first evaluation meeting, the Evaluation Team decided to short-list and removed two proposals from consideration. The reasoning is documented in the attached memo. Advanced Correctional Healthcare and Turn Key Health Clinics LLC were invited to submit a first round of Best and Final Offers (BAFOs). These BAFOs were reviewed during the second Evaluation Team meeting which resulted in the decision to pursue a second BAFO with Turn Key Health Clinics LLC. The attached Evaluation Narrative describes the evaluation and scoring between Advanced Correctional Healthcare and Turn Key Health Clinics, LLC.

Weighted evaluation was used to evaluate and score the two proposals: Experience, Expertise, and Reliability was worth a maximum score of 30 subjective points; and Method of Performance and Contractor Support was worth a maximum score of 20 subjective points. Cost points, worth a maximum 50 points, were computed by the Purchasing Department.

The Scoring Form, Evaluation Narrative explaining the subjective scores, and the Cost Evaluation are attached to this memo. It is noted for the record that the Evaluation team scored subjective points, worth a maximum of 50 total points, without knowledge of cost point scores.

The outcome of the evaluation is this:

The highest score is earned by Turn Key Health Clinics LLC. As such, the proposal from Turn Key Health Clinics LLC is the “lowest and best” offer. The Boone County Sheriff’s Office is recommending award to Turn Key Health Clinics LLC of Oklahoma City, Oklahoma, see attached e-mail dated 4/24/24 from Captain Damon Reynolds.

The contract period will run from June 01, 2024 through May 31, 2025 with four (4) one-year renewal options available after this initial period.

This is considered a Term and Supply contract for the Sheriff’s Office. A total \$998,600.00 is budgeted for 2024. Payments will reference the following coding:

- 1255 – General Fund Detention Operations/85620 – Other Medical

This memo documents results of discussion with the Evaluation Team reviewing the four proposals received by the County in response to RFP 05-13MAR24 for Detainee Medical Services -Term & Supply. Four proposals were received:

- (1) Advanced Correctional Healthcare of Franklin, Tennessee
- (2) Turn Key Health Clinics, LLC of Oklahoma City, Oklahoma
- (3) Vital Medical Services, LLC of Glendale, California
- (4) Superior Blessings, LLC of Columbia, Missouri

The proposals from Vital Medical Services and Superior Blessings were deemed unacceptable and were removed from further consideration for award. The reasons follow.

Vital Medical Services: Vital Medical Services indicated that its proposal includes a \$100,000.00 pool requirement (see Supplier Note from BoCoMoBids, item 5.1.1, and page 29 of proposal). RFP 05-13MAR24 is clear that the County offers a \$50,000.00 pool (RFP paragraphs 3.1.2(j), 3.1.2(k), 3.23.10, and 3.23.10(d)). None of the references Vital Medical Services identified were for County Jails – they were for smaller police departments; the services were not comprehensive medical and mental health services. Vital Medical Services is based out of California. Most if not all of their references are in California. Services provided to references include pre-book screenings, forensic evidence collection, and communicable disease and exposure testing. None of the described services are for running a Jail medical office 24X7 as is required by RFP 05-13MAR24. A “Chief Medical Officer for Missouri Operations” is identified as a job category but there are no details about the person who would be hired to fill that position. This also indicates that there is no one currently working for Vital Medical Services who is performing as the Chief Medical Officer for Missouri Operations. In general, details about how medical services would be delivered are very generalized and not specific. The proposal was not lowest priced and since the vendor wants to double-the available pool, their \$863,250.60 total should be raised \$50,000.00 to acknowledge their inflated pool request resulting in a total of \$913,250.60. Detail on personnel is scant. No personnel are named. There are no resumes or job descriptions except for one resume for Dr. Angelique Campen who is the National Chief Medical Officer. It's assumed that she would oversee the Chief Medical Officer for Missouri; she would have little to do with daily operations managing medical services at the Boone County Jail; whereas there is no name or resume for the Chief Medical Officer for Missouri who, it is assumed, would have more direct contact with daily operations at the Boone County Jail. The lack of detail, lack of relevant references, and contradiction about the pool fund prompted the Evaluation Team to determine the proposal from Vital Medical Services as being unacceptable for further consideration.

Superior Blessings LLC: There are several offers contained in this one proposal from Jennifer Feltner. See the attached chart to illustrate the 5 different options the County can consider for provision of Detainee Medical Services at the Boone County Jail ranging in pricing from \$668,000.00/year to \$736,000.00. Superior Blessings agrees to provide services as required in the RFP, but actual staffing plans are not detailed. Superior Blessings intends to hire existing medical services staff performing for the incumbent contractor. It's assumed that this means Superior Blessings intends to recruit and hire nursing staff currently employed by Advanced Correctional Healthcare, but there's no detail about how or when this will be accomplished. Much of the detail about staffing expertise that Superior Blessings brings is focused on Jennifer Feltner who is the owner and CEO of Superior Blessings. The proposal promises a cost-effective approach to managing the Jail's medical services that will save the County money, however it's not clear how this goal will be reached because the proposal lacks detail about performance methodology and staffing. No references are provided that speak to Superior Blessings' performance as a health care provider except for one home-care reference. Other references are from banking and loaning institutions. The organizational chart includes two people by name – Jennifer Feltner and Angelica Yager, VP of Admin Operations. Crucial medical positions (RN, LPN, Psychologist, Nurse Practitioner, the Pharmacy) have no one identified. There are few job descriptions for any of the essential medical positions. Much material in the proposal is directly copied from other resources (Sacramento County for example). There are references in the proposal to serving the Jail "and the Juvenile facility." RFP requirements do not include provision of medical services at the juvenile facility. Nothing further was said in the proposal about extension of service to the juvenile facility. Because of the lack of appreciable detail about staff, staff expertise, experience running a Jail medical office 24X7, and detail about how services would be performed, the Evaluation team concluded that the proposal from Superior Blessings didn't meet the threshold for continued evaluation.

Evaluation Report RFP 05-13MAR24 -Detainee Medical Services for the Boone County Jail - Term & Supply

OFFEROR #1: Turn Key Health Clinics LLC

- The proposal from Turn Key Health Clinics LLC is deemed responsive to the mandatory terms and conditions of the RFP.

EXPERIENCE, EXPERTISE and RELIABILITY: SCORE 25 of 30

Strengths:

- Been in operation 15 years (since 2009);
- Serves more than 100 correctional facilities in the Central US, several counties in Missouri (Buchanan, Christian, Franklin, and Pettis). Bringing Cole County into the service network in April 2024;
- Experienced with NCCHC and ACA accreditation standards as well as DOJ mandates. Operate in accordance with NCCHC and ACA standards;
- Lead officers maintain Certified Correctional Health Professional status with NCCHC;
- Long history/experience providing correctional healthcare (140 years collectively leadership team)
- Low litigation history – shared details;
- Contacted three Missouri references (Buchanan County, Pettis County, and Christian County) and 2 out-of-state references (Logan County, OK and Saline County, AR). All references spoke highly about Turn Key Health Clinics, and indicated their Jail facilities medical offices had improved under Turn Key. Turn Key is responsive, provides required staffing and is a good contractor and support to their jails;
- References are jails like Boone County jail;
- Experienced administrative and medical staff – very familiar with working in a correctional environment.

Concerns:

- None

METHOD OF PERFORMANCE and CONTRACTOR SUPPORT: SCORE 20 of 20

Strengths:

- Mid-level practitioner is on-call 24X7 plus on the weekly staff schedule for 4 hours on Fridays;
- Nursing includes RN's and LPN's;
- Providing Detox training and Sheriff staff training at no additional costs including no cost for materials and supplies with reasonable advance notice for training;
- Provide daily operations reports – this would be new and beneficial;
- Pharmacy management process provides prescription oversight;
- Screen for inmate's private insurance as well as Medicaid/Medicare coverage at intake;
- An initial comprehensive mental health assessment will be conducted within 14-days after intake;
- Will perform initial evaluation of all detainees within 4-hours of arrival at the Jail, and a comprehensive health assessment in 14-days.
- Plan to check routinely on inmates with chronic conditions;
- Plan to deliver most care on-site or through mobile service – eliminate barriers to exchanging information with local hospitals and care providers. Routine medical specialty services (lab, x-ray, EKG, ultrasound) to be performed on-site when feasible, and will identify as many specialist providers willing to conduct on-site clinics;

- Drug policy kept on-site in Charge Nurse’s office – provided copy of policy in proposal;
- Medical cost containment plan is patient-oriented that ties into discharge planning for inmates needing mental health services;
- Pharmaceuticals cost containment will follow direction of Boone County Jail retaining IHS or shifting to Diamond Pharmacy – will adhere to NCCHC and ACA standards;
- Will implement a site-level Continuous Quality Improvement (CQI) Committee to identify healthcare problems and how to correct in adherence with NCCHC and ACA standards;
- Turn Key provides 2-hours of psychiatry service per week;
- Will implement a Client-Liaison program for the Boone County Jail. Client liaison will be focused on service delivery and meeting performance and contract expectations.

Concerns:

- None

OFFEROR #2: Advanced Correctional Healthcare

- The proposal from Advanced Correctional Healthcare is deemed responsive to the mandatory terms and conditions of the RFP.

EXPERIENCE, EXPERTISE and RELIABILITY: SCORE 22 of 30

Strengths:

- Been in operation 22 years (since 2002);
- Have served Missouri since 2005;
- ACH has served the Boone County Jail since June of 2016;
- Deliver services that may be audited against ACA and NCCHC standards;
- Provided supportive references from Missouri (Jackson County and Phelps County) and letter of support from Genessee County (MI) Jail;
- Experienced professional staff familiar with working in correctional environment;
- ACH’s current nursing staff is excellent to work with;
- Included workplace drug policy in proposal – says it applies to subcontractors too.

Concerns:

- Does not routinely meet contractual nursing staffing requirements under current contract;
- Jail staff has to fill-in when ACH staffing levels are not met;
- Several of Turn Key Health Clinic LLC’s references were previous ACH clients who had switched to Turn Key Health Clinic primarily because of unexpected requests from ACH for cost increases and staffing that failed to meet required levels, in other words, for experience similar to that of the Boone County Jail with ACH.
- Lawsuit details were not disclosed without the County signing a Non-Disclosure Agreement.
- Has not performed annual audit as required in the current contract with Boone County.

METHOD OF PERFORMANCE and CONTRACTOR SUPPORT: SCORE 13 of 20

Strengths:

- Medical personnel (nursing staff) will be proficient, skilled and familiar with working in the Boone County Jail since ACH is the incumbent contractor;

- ACH allows practitioners to operate without restriction on medical care delivered to inmate;
- ACH allows economies of scale to help reduce the costs of medical care and keep the inmate healthy;
- Strong relationship with national pharmaceutical companies that allows ACH to pass cost savings on to Boone County;
- Has detailed Quality Control and Tracking Process with reporting. Does monthly CQI meetings with Jail.
- Will provide CPR training for 50 officers including CPR cards per year.

Concerns:

- Bill scrubbing is currently done free of charge. ACH requests \$17/claim only if there is a savings under a new contract;
- Only going to use RN's to meet nursing staffing. Question ACH does not address is where current LPN staff is used or placed if not serving at the jail;
- Practitioner hours are less than Turn Keys, i.e. 2 hours compared to 4 hours;
- ACH initially took exception to providing 24X7 on-call mental health service. The BAFO #1 response says the County can contact "the practitioner" that is on call 24X7. The response is still ambiguous because this can be read to be the medical practitioner, not the mental health practitioner. It is not clear like it should be that the mental health practitioner is on call 24X7.
- ACH indicates it will meet the required Qualified Mental Health Professional (QMHP) services requirement however under the current contract, ACH does not meet the level of service required for QMHP coverage.

SUMMARY:

Turn Key Health Clinics LLC presented a strong proposal. Turn Key is scored 25 of 30 points in the area of Experience, Reliability and Contractor support. Turn Key follows National Commission on Correctional Health Care (NCCHC) and American Correctional Association (ACA) standards; administrative and professional staff are certified. All references contacted said the same things about Turn Key Health Clinics – the company is good to work with, meet staffing requirements, and are a good partner. All references indicated they would choose Turn Key again to run their jail medical services. Turn Key says they pride themselves on their transparency. They provided detail about lawsuits in their proposal. Their proposal for Method of Performance scored 20 out of 20 maximum points. Turn Key offers 4 hours on-site staffing for their mid-level practitioner and will use a combination of RN's and LPN's to meet required 24X7 nursing service levels. They offer continuous quality improvement with the addition of daily reporting to the Sheriff which is an additional benefit. Turn Key will conduct a comprehensive mental health evaluation within 14 days of intake and with on-going mental health care oversight through release. Turn Key says it will cultivate relationships and communicate with local health and mental health services providers to ensure cost reductions while the inmate is at the jail and forge a pathway to on-going care after the inmate's release. A unique benefit Turn Key offers is the Client Liaison who will be assigned to the Boone County Jail and will focus on meeting Turn Key's contractual performance expectations.

Advanced Correctional Healthcare is a reputable firm that has been the County's medical services provider at the Jail for several years. Nursing staff has been excellent to work with. Advanced Correctional Healthcare is scored 22 of 30 points in the area of Experience, Reliability and Contractor support. Advanced Correctional Healthcare (ACH) loses points because the Boone County Jail has experienced instances where nursing staff has not been at contracted levels, at times causing jail staff to take-up the slack to cover the absence. While ACH provides a credit for staffing not meeting agreed-to levels, it would be preferred that staffing levels were met. Additionally, it was concerning to hear several jails that had shifted away from ACH for reasons similar to

Boone County's experience with ACH, i.e., ACH wanted additional funding and otherwise failed to meet committed levels of staffing. ACH initially proposed to use County pool funds to cover more items and services that ACH currently covers; this was corrected by ACH in its BAFO #1 response, but it still leaves a negative impression. Additionally, ACH would not disclose its lawsuits history without the County signing an NDA whereas Turn Key provided detail in its proposal about its lawsuits history as requested in the RFP. ACH is scored 13 out of a maximum 20 points for Method of Performance. In comparison to Turn Key ACH offers half the number of weekly scheduled mid-level practitioner hours. ACH is no longer planning to employ LPN staff instead proposing to use RN's for all nursing services delivered at the jail; this leaves the question about what happens to current LPN staff who perform well for the jail. Turn Key has a 24X7 on-call list for the physician, psychiatrist and licensed mental health counselor whereas ACH's 24X7 coverage on mental health service is not described as clearly ensuring coverage and access as needed. ACH fails to meet the requirement in the current contract regarding Qualified Mental Health Professional services and the Sheriff's office is concerned that ACH will not meet the requirement under a new contract. The Sheriff's Office has not received an annual audit from ACH regarding its performance under the current contract as required, causing concern about provision of the required audit under a new contract. All things considered, the proposal from Turn Key Health Clinics compared to the proposal from Advanced Correctional Healthcare presents a better overall opportunity for the County to staff and manage detainee medical services.
