MEMORANDUM

RE: Award of County Contract C000893 from RFB 47-16NOV24 for Active Shooter Kit Supplies (Term & Supply) for the Boone County Emergency Management Department - Bound Tree Medical

Purchasing requests the award of Boone County contract C000893 as a result of competitive bid RFB 47-12NOV24 for Active Shooter Kit Supplies, Term & Supply, for the Boone County Emergency Management Department. Four (4) bids were received:

1. Bound Tree Medical, LLC of Dublin, Ohio
2. North American Rescue, LLC of Greer, South Carolina
3. Life-Assist of Rancho Cordova, California
4. CPR Savers & First Aid Supply

The bid from Life-Assist has been determined non-responsive for failure to submit firm renewal pricing. In response to pricing adjustment quotes for each of the three renewal options, Life-Assist stated in their bid "Life-Assist will pass all price adjustments at the time of renewal based on manufacturer price changes." The RFB clearly required bidders to "...respond with a firm, fixed percentage of increase or decrease..." The response from Life-Assist for renewal pricing will be an increase but it is not a firm percentage as required. As such the total maximum potential liability of the County contracting with Life-Assist would be unknown. Their bid was removed from further consideration.

The remaining three bids have been reviewed by the Purchasing Department and the Boone County Emergency Management Department.

It is noted for the record that Bound Tree Medical LLC's bid for line item 4.10.12, the Nasopharyngeal Airway 28F with Lubricant is non-responsive because the Curaplex Airway product does not include lubricant as required by the RFB. Bound Tree Medical LLC's bid for this item could not be considered for award. Additionally, Bound Tree Medical LLC is also non-responsive for item 4.10.3, the CAT Kydex Belt Holder. The RFB required that the item have the ability to be mounted vertically or horizontally. The CAT belt holder bid by Bound Tree Medical does not have the capability of being

mounted vertically or horizontally. Bound Tree Medical bid a NAR 30-0160 which is only vertically mounted.

Additionally, it is noted for the record that the RFB referred to product code NAR10-0015 for line item 4.10.13, the Hyfin Vented Chest Seal Twin Pack. This product code is a single pack and should have instead been the NAR 10-0037. Pricing for this item has been adjusted so all bid pricing reflects twin-pack pricing for the cost evaluation:

North American Rescue bid a twin pack price (NAR 10-0037) – their quoted price of \$12.08 per each twin-pack was not adjusted. CPR bid \$10.95 per single pack. Their pricing was multiplied by “2” to get “\$21.90” that was used in the cost evaluation. Bound Tree Medical LLC bid \$9.73 per single-pack. Bound Tree Medical LLC’s pricing was multiplied by “2” to get “\$19.46” used in the cost evaluation to compare twin-pack pricing across the board.

The Bid Tabulation and the Cost Evaluation follow this memo. The County will award to two bidders who are low-bid for the identified line item as follows. No award will be made for line items 4.10.2 (bag strap), line item 4.10.9 (triage tags) and 4.10.10 (webbing).
